## **Cash On Your Pass Sweepstakes**

## **Official Rules**

I-77 Mobility Partners LLC ("<u>Sponsor</u>") is pleased to offer the Cash On Your Pass Sweepstakes (the "<u>Sweepstakes</u>"). In order to participate in the Sweepstakes, you must agree to these rules (the "<u>Official Rules</u>").

PLEASE CAREFULLY READ THE OFFICIAL RULES BEFORE PARTICIPATING IN THE SWEEPSTAKES. THE OFFICIAL RULES CONTAIN IMPORTANT INFORMATION ABOUT THE SWEEPSTAKES AND SPONSOR'S OBLIGATIONS WITH RESPECT TO THE SWEEPSTAKES.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. MAKING A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1) **ELIGIBILITY**: The Sweepstakes is open only to legal residents of the State of North Carolina, who are at least 18 years of age or older as of date of entry, who follow all of the terms and conditions set forth in these Official Rules.

Employees, officers and managers of Sponsor and their respective parent companies, affiliates, subsidiaries, advertising, contest, fulfillment and marketing agencies, their immediate families (parent, child, sibling & spouse and their respective spouses, regardless of where they reside), and persons living in the same households as such individuals (whether related or not) are not eligible to participate in the Sweepstakes. By participating, you agree to these Official Rules and to the decisions of the Sponsor, which are final and binding in all respects. The Sweepstakes is void in any state not listed above and where prohibited by law, rule or regulation. All federal, state and local laws and regulations apply to the Sweepstakes.

By entering the Sweepstakes, you accept all of the terms and conditions of these Official Rules. Each such person who enters the Sweepstakes shall be referred to as an "Entrant." An Entrant's entry must fulfill all Sweepstakes requirements, as specified, to be eligible to win a Prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the Sponsor. If an Entrant uses fraudulent methods or otherwise attempts to circumvent the rules such submission may be removed from eligibility for the Prize and/or the Giveaway at the sole discretion of the Sponsor.

The entry period for the Sweepstakes (the "Entry Period") begins on **August 1, 2019 (12:00 a.m. EST)** and will end at a date and time announced by the Sponsor on its website at least one week in advance (the "End Date"). If an Entrant submits an entry by mail, it must be postmarked no later than the End Date. Entry times will be determined using Sponsor's computer, which will be

- the official clock for the Sweepstakes. Normal time rates, if any, charged by Internet service provider will apply. There is a limit of one (1) entry per person by any methods or combination of methods of entry during Entry Period. No purchase is necessary.
- 3) <u>GIVEAWAY</u>: Each Entrant who opens a new Account (unless such Account constitutes a permanent declaration of HOV 3+) on or after August 1, 2019 and who completes the Sweepstakes registration form online at the Website shall receive a Ten US Dollars (\$10.00) credit on the applicable Account (the "<u>Giveaway</u>") after driving through five (5) segments of I-77 Express Lanes.
- 4) ACKNOWLEDGEMENTS, DISCLAIMERS, AND WAIVERS: By submitting an entry, Entrant warrants and represents that he/she consents to the submission and use of the entry in the Sweepstakes and to its use as otherwise set forth herein. Each Entrant, by participating, agrees to be fully and unconditionally bound by these Official Rules, and the Entrant represents and warrants that he/she meets the eligibility requirements set forth herein. In addition, the Entrant agrees to accept the decisions of the Sponsor as final and binding as it relates to the Sweepstakes. The Sweepstakes is subject to all applicable federal, state and local laws.
- 5) SELECTION AND NOTIFICATION OF SWEEPSTAKES PRIZE WINNERS: The Sponsor will periodically select twenty (20) winners of a One Hundred US Dollars (\$100) (each, a "Prize"). If the Entrant has an Account and enters the promotion via the Website, the Prize will be credited to the applicable Account (each a "Prize"). If the Entrant submits an entry by mail, the Prize will be mailed to the address provided in the entry submission. Prizes are nontransferable. The Sponsor shall announce the dates of the Prize selections no less than five (5) days prior to the actual selection. Potential winners will be notified by phone and/or e-mail, in Sponsor's discretion, and may in Sponsor's discretion be required to complete and return to Sponsor an Affidavit of Eligibility/Release of Liability. By entering the Sweepstakes you understand that the Sponsor, anyone acting on behalf of the Sponsor, or its respective licensees, successors, assigns, and affiliates will have the right, where permitted by law, without any further notice, review, compensation, or consent to print, publish, broadcast, distribute, and use, worldwide in any media now known or hereafter in perpetuity and throughout the World, your entry, including, without limitation, the entry and name, portrait, picture, voice, likeness, image or statements about the Sweepstakes, and biographical information as news, publicity or information and for trade, advertising, public relations and promotional purposes without any further compensation.
